The Board of the Company is pleased to announce that the change of English name of the Company from “Sinogreen Energy International Group Limited” to “Jimei International Entertainment Group Limited” and the secondary name of the Company from “中國綠能國際集團有限公司” to “集美國際娛樂集團有限公司” has become effective on 23 December 2014.

The logo of the Company has been changed to “ ” with effect from 15 January 2015.

With effect from 9:00 a.m. on 21 January 2015, the stock short name for trading in the Shares on the Stock Exchange will be changed from “SINOGREEN EN” to “JIMEI INT ENT” in English and from “中國綠能國際” to “集美國際娛樂” in Chinese. The stock code of the Company will remain as “1159”.

Reference is made to the announcement of Jimei International Entertainment Group Limited (formerly known as Sinogreen Energy International Group Limited) (the “**Company**”, together with its subsidiaries, the “**Group**”) dated 6 November 2014, the circular (the “**Circular**”) of the Company dated 21 November 2014, and the announcement of the Company relating to the poll results of the SGM dated 18 December 2014 in relation to, among other matters, the change of name of the Company (the “**Change of Company Name**”). Unless otherwise specified in this announcement, capitalised terms used herein shall have the same meanings as those defined in the Circular.

## **CHANGE OF COMPANY NAME**

Subsequent to the passing of a special resolution by the Shareholders at the SGM held on 18 December 2014 approving the change of English name of the Company to “Jimei International Entertainment Group Limited” and the secondary name of the Company to “集美國際娛樂集團有限公司”, the Board is pleased to announce that the Certificate of Incorporation on Change of Name and the Certificate of Secondary Name of the Company were issued by the Registrar of Companies in Bermuda on 31 December 2014, certifying the change of English name of the Company from “Sinogreen Energy International Group Limited” to “Jimei International Entertainment Group Limited” and the secondary name of the Company from “中國綠能國際集團有限公司” to “集美國際娛樂集團有限公司” with effect from 23 December 2014.

The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 13 January 2015, certifying the registration of the said new name of the Company in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong) with effect from that date.

## **EFFECT ON CHANGE OF COMPANY NAME**

The Change of Company Name will not affect any rights of the Shareholders. All existing share certificates of the Company in issue bearing the former name of the Company will, after the Change of Company Name becoming effective, continue to be effective as documents of title to the Shares and will continue to be valid for trading, settlement, registration and delivery purposes. Accordingly, there will not be any arrangement for free exchange of the existing share certificates of the Company for new share certificates bearing the new name of the Company. New share certificates will be issued under the new name of the Company with effect from 23 December 2014.

## CHANGE OF COMPANY LOGO

The Board has resolved to adopt one of the registered trademarks of Jimei Development Holdings Limited in Hong Kong as a new logo of the Company with effect from 15 January 2015 to reflect the Change of Company Name. The Company has obtained all necessary right to use the new logo. The new logo will be printed on all corporate documents of the Company, including new Share certificates, promotional materials, interim and annual reports, announcements and corporate stationery to be issued by the Company after the adoption of new Company's logo becoming effective.
