The Company has made an application to the High Court of the Hong Kong Special Administrative Region (the “High Court”) for judgment in relation to its claims for restitution for total failure of consideration and rescission in connection with the Acquisition Agreement, a written judgment was handed down by the High Court on 20 June 2013 in favour of the Group. It was ordered by the High Court that final judgment be entered against the Vendors in default of defence that the Company is entitled to and granted the declaration that: –

1. The Company was entitled to terminate the Acquisition Agreement for total failure of consideration.
2. The Company was entitled to the return of Convertible Bonds in a total of HK\$112,800,000.
